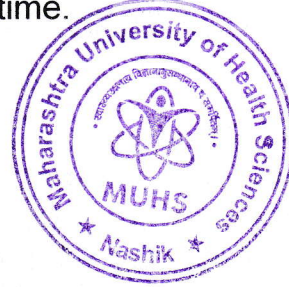
Sir,
